## The Global Goeconomics Summit

Structured as a hybrid of a Summer Academy, Strategy Summit, and Career Platform, HGW25 offers high-density learning through lectures, electives, and closed-door roundtables — culminating in curated learning, networking and mentoring opportunities.

- **Thrive** — Reimagine strategy through law, finance, and regulatory design
- **Drive** — Gain agency, build institutions, and lead at the power–wealth nexus

## *Trump Six Months On: Goeconomics in a Fractured Global*

Helsinki Goeconomics Week 2025 (HGW25) is the flagship program of the Helsinki Goeconomics Society—a high-trust forum for learning, strategy, and exchange.

Held six months into the Trump administration, HGW25 brings together legal, policy, and business leaders to navigate and shape today's geoeconomic order.

### ■ What is Goeconomics?

Goeconomics is *realist* economics: the fusion of economics and politics, where states, firms, and investors compete for *wealth* and *power*, grounded in *geography*.

### ■ What You Will Learn

HGW25 delivers applied, cross-functional training through lectures, electives, and expert roundtables—complemented by scenario exercises and policy case labs—equipping participants with tools to address emerging geoeconomic challenges:

- **Survive – Navigating Geoeconomic Risk**  
Learn to anticipate and respond to coercive economic tools and systemic vulnerabilities:
  - How to assess exposure to sanctions, export controls, and capital restrictions
  - How to apply compliance diplomacy and mitigate jurisdictional risk
  - How to build legal and operational resilience into supply chains and investment decisions
- **Thrive – Designing Geoeconomic Strategy**  
Gain frameworks for turning uncertainty into strategic advantage:
  - How to navigate and shape trade rules, investment regimes, and regulatory environments
  - How to engage with capital flows, shadow banking, and algorithmic finance
  - How to align legal, financial, and policy tools to drive cross-border outcome
- **Drive – Building Geoeconomic Agency**  
Develop the ability to lead and design the mandates and systems others depend on:
  - How to shift from risk response to rule-making and mandate design
  - How to shape decisions across legal, policy, and capital domains
  - How to build a long-term leadership path at the power–wealth nexus
